ADDENDUM / CLARIFICATION NOTE

to the Invitation for Expression of Interest (IEOI) dated December 11, 2025

This Addendum is issued with reference to the Invitation for Expression of Interest (“IEOI”) dated December 11, 2025, issued by the Resolution Professional (“RP”) for inviting Expressions of Interest from eligible Prospective Resolution Applicants (“PRAs”) in respect of the Corporate Insolvency Resolution Process (“CIRP”) of ACCIL Corporation Private Limited (the “Corporate Debtor/ Company”).

It is hereby clarified for the information of all Prospective Resolution Applicants that the following modifications / clarifications shall apply to the formats contained in the IEOI:

1. **Annexure A – Section 29A Undertaking**

The jurisdiction clause contained in Clause 10 of Annexure A shall be read as follows:

“That this undertaking shall be governed in accordance with the laws of India and the courts and tribunals in Jaipur shall have exclusive jurisdiction over any dispute arising under this undertaking.”

Further, PRAs are advised to ensure payment of **minimum stamp duty of INR 200** in respect of Annexure A.

2. **Annexure D – Format of Confidentiality Undertaking**

The jurisdiction clause contained in Clause 16 of Annexure D shall be read as follows:

“That this undertaking shall be governed in accordance with the laws of India and the courts and tribunals in Jaipur shall have exclusive jurisdiction over any dispute arising under this undertaking.”

3. **Affidavit regarding Section 29A of the Insolvency and Bankruptcy Code, 2016**

The jurisdiction clause contained in Clause 14 of the aforesaid affidavit shall be read as follows:

“This affidavit shall be governed in accordance with the laws of India and the courts and tribunals in Jaipur shall have the exclusive jurisdiction over any dispute arising under this affidavit.”

All other terms, conditions, timelines, and requirements as set out in the IEOI dated December 11, 2025 shall remain **unchanged and continue to be in full force and effect**.

This Addendum shall form an **integral part of the IEOI** and shall be read in conjunction therewith.
